### Position Summary

The District has three (3) seasonal positions available for general labourers in the Parks Department. These eight (8) month positions are anticipated to be from mid-March/early-April through November 30, 2024.

Reporting to the Operations Superintendent or Parks Foreman, these positions perform a variety of general and specific labour-type duties including the safe and efficient operation of municipal vehicles, small tools and equipment.

### Qualifications

- Completion of Grade 12 or equivalent education and relevant experience
- Valid Class 5 BC Driver's Licence and safe driving record
- Ability to comply with and follow safety procedures, legislation, regulations and direction
- Knowledge of safe work practices
- Physical agility and ability to complete duties requiring physical effort
- Ability to work outdoors in a variety of weather conditions
- Proficient written and oral communication skills, and the ability to exercise diplomacy, courtesy and tact
- Ability to work in a construction environment

A Class 3 Driver's Licence with air break endorsement, a Level 1 First-aid Certificate, computer literacy, and traffic control certification is desired. The successful applicant must provide the District with a driving record and criminal record check prior to the commencement of work.

### Additional Information

These are union positions, and relevant provisions of the CUPE Collective Agreement pertain. The normal workday shall consist of a scheduled period of eight (8) hours of work between the hours of 7:00 am and 5:00 pm. The normal work week shall consist of five (5) such consecutive days in a seven (7) day week. The hourly wage is \$27.44 per hour, plus 17.5% of total earnings in lieu of sick time, vacation time, statutory holidays, and benefits.
